

**Notice is hereby given pursuant to Article 7, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B) that a public hearing of the Sabine Parish School Board in Sabine Parish will be held at its regular meeting place in the board room of the Sabine Parish School Board, located at 695 Peterson Street, Many, LA on Monday, September 9, 2019 at 5:45 p.m. to consider levying additional or increased millage rates without further voter approval or adopting the adjusted millage rates after reassessment and rolling forward to rates not to exceed the prior year's maximum. The estimated amount of tax revenues to be collected in the next year from the increased millage is \$4,980,666, and the amount of increase in taxes attributable to the millage increase is \$958,831. A breakdown of these figures by district occurs in chart below.**
